

# **Overview of the Surplus Property Process**

Before a school district can sell or lease real property, Education Code Sections (EC §) 17388-17389 require that a specific process be followed



### Responsibilities of the Committee


EC § 17390 then provides the responsibilities of the Committee:

- a. Review the projected school enrollment and other data as provided by the district to determine the amount of surplus space and real property
- b. Establish a priority list of use of surplus space and real property that will be acceptable to the community
- c. Cause to have circulated throughout the attendance area a priority list of surplus space and real property and provide for hearings of community input to the committee on acceptable uses of space and real property, including the sale or lease of surplus real property for childcare development purposes pursuant to EC § 17458
- d. Make a final determination of limits of tolerance of use of space and real property
- e. Forward to the district governing board a report recommending uses of surplus space and real property






#### **County Assessors Map**

# What is Panhandle?

- Panhandle Development Project
  - It is located adjacent to City lands on the west and east and adjacent to County lands on the north and south.
  - It is bounded by Elkhorn Boulevard on the north, Sorento Road and East Levee Road on the east, and Del Paso Road on the south.

The District owns 5 parcels in the Panhandle PUD. This aerial view shows the approximate boundaries of all 5 parcels owned by the District. The blue dashed line depicts the approximate location of the SMUD easement and the boundary between ENEC and Village 13.




### Panhandle Parcels: Possible Revenue Stream





### Entire Site - 9.05 Acres




#### Without School Site Approximately 7.05 acres

### Smythe Arts Academy of Arts and Science 7-8 Survey Results


### Methodology

- Worked with site leadership on using "typical" school communication processes
- Open for 10 days
- Multiple reminders
- Translated into Spanish and Hmong

### Results

- 26 responses
  - 11 English Survey
  - 15 Spanish Survey
  - 0 Hmong Survey
- 100% agreed that they would continue in the Smythe program if the school was relocated closer to their home or neighborhood
