Updates: ELPAC, Reclassification, and Data – presented by Timothy Tibbs as of March 13, 2023, there has been 2,326 of our 7,200 students have been tested the ELPAC so far this is grades levels Kinder – 12th. The Summative ELPAC contains of the following domains – Listening, Speaking, Writing, and Reading. We are about 30% done but still have two months and will continue testing through May 31, 2023, our goal is to complete 100%.

- Reclassification We have 520 English learners have been Reclassified as of March 13, 2023. In the last two months we have reclassified around 200 plus students.
- Tutoring for English learners is available and it's called Willow Way Tutoring its available in multilingual for students. If you are interested in your student participating. Schedule Mondays 4:00 pm 8:00 pm and Tues-Friday 4:00 pm 6:00 pm.
- Current Attendance EL Student rate is at 90% and EO students is at 89.9%. The overall attendance rate students in TR
 is 90.5%

ELD PILOT Adoption for Secondary Students – Presenter Angela Lemenager, EL Program Specialist the ELD Pilot program update was presented this past year to secondary teachers and students and it was a success. The ELD Pilot Universal Read 180 program will be implemented next year 2023-24 to ELD 1a/1b., 1-3. The board approved adopting the Read 180 Universal Program which will be implemented in all secondary ELD 1a/1b, ELD 1, ELD 2, and ELD 3 courses beginning in 2023-24 school year.
