DELAC Roles & Responsibilities - Each LEA with 51 or more EL students must form a DELAC unless the district designates for this purpose a subcommittee of an **existing districtwide** advisory committee. Parents or guardians, or both, of pupils of limited English proficiency who are not employed by the district shall constitute the majority of the DELAC.

## Responsibilities

(1) Master Plan - Development of a district master plan for education programs and services for English learners. The district master plan will take into consideration the school site master plans. (2) Needs Assessment - Conducting of a district wide needs assessment on a school-by-school basis. (3) Goals & Objectives Establishment of district program, goals, and objectives for programs and services for English learners. (4) English Learner Compliance - Development of a plan to ensure compliance with any applicable teacher and/or teacher aide requirements. (5) Review and comment on the school district reclassification procedures. (6) Parent Notifications - Review and comment on the written notifications required to be sent to parents and guardians. (7) Local Control Accountability Plan (LCAP) If the DELAC acts as the English learner parent advisory committee under California Education Code Sections 52063(b)(1) and 52062(a)(2), the DELAC shall also review and comment on the development or annual update of the Local Control and Accountability Plan (LCAP). \*
