## KINDERGARTEN REGISTRATION 2024-2025

**Beginning Monday, January 8, 2024, schools in the Twin Rivers Unified School District (TRUSD) will be accepting Kindergarten and Transitional Kindergarten registration for the 2024-2025 school year.**

To enter kindergarten, a child must meet the following requirements for admission as established by the Education Code and the policies and administrative regulations of TRUSD. The requirements for enrollment are as follows:

- Completed Student Enrollment Form
- Completed Home Language Survey
- PROOF OF RESIDENCY.** Acceptable documents are utility bills or payment receipts; rental or lease agreements; property tax receipts; pay stubs; voter registration; correspondence from a government agency; or declaration of residency executed by the parent/guardian.
- PROOF OF AGE.**<sup>1</sup> Acceptable documents are a birth certificate, baptismal certificate, passport, immigration certificate, Bible record, or when none of these documents are available, an affidavit from the parent/guardian. In order to enter **kindergarten**, your child must turn **five (5) years of age on or before September 1, 2024**. Children turning five (5) years of age September 2, 2024 through June 2, 2025 will be enrolled in Transitional Kindergarten.)
- PROOF OF REQUIRED IMMUNIZATIONS**<sup>1</sup>

### Students Admitted at TK or K Need:

- **Diphtheria, Tetanus, and Pertussis (DTaP, DTP) - 5 doses** (4 doses OK if one was given on or after 4<sup>th</sup> Birthday)
- **Polio (OPV or IPV – 4 doses** (3 doses OK if one was given on or after 4<sup>th</sup> birthday)
- **Hepatitis B – 3 doses**
- **Measles, Mumps and Rubella (MMR) - 2 doses**  
(Both given on or after 1<sup>st</sup> birthday)
- **Varicella (Chicken Pox) - 2 doses**

Please note that Personal Beliefs Exemption from required vaccinations will not be accepted. Only a licensed Medical Doctor (MD) or Doctor of Osteopathic Medicine (DO) may provide a medical exemption.

**HEALTH EXAM & DENTAL CHECKUP.** Children must have a physical exam and dental checkup their first year of school (forms included in the registration packet). If not already done, please schedule these appointments as soon as possible.

Please call the school office with any questions. We look forward to working with your family to ensure a successful school year for your child.

\*\*Starting January 1, 2021 Medical exemptions can only be issued through the California Immunization Registry Medical Exemption website (CAIR-ME) by physicians licensed in California. Schools and childcare facilities may only accept from parents new medical exemptions that are issued using CAIR-ME. Please call the school office with any questions. We look forward to working with your family to ensure a successful school year for your child.
