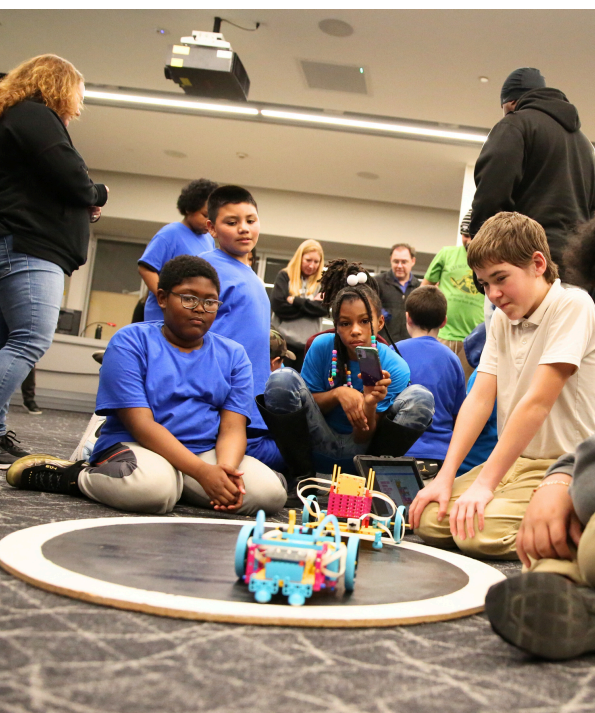

Kawm

3.1 CAASPP

Txhua lub caij nplooj ntoos hlav, feem coob ntawm cov me nyuam kawm ntawv hauv California koom rau hauv lub xeev no, California Kev Soj Ntsuam (Student Performance and Progress (CAASPP) lawv. Txoj kev ntsuam xyuas hauv CAASPP lawv muab cov ncauj lus rau cov xib fwb, cov niam txiv/cov tswj fwm thiab cov me nyuam kawm ntawv txog kev kawm ntawv qib siab thiab kev nyeem ntawv rau cov me nyuam kawm ntawv qib siab thiab cov hauj lwm kav ntev. Nyob qeb 3 txog qib 11 thiab qib 11, feem coob ntawm cov tub ntxhais kawm ntawv yuav siv cov Smarter Balanced hauv internet sib tw (ELA) thiab zauv. Txawm li ntawd los, cov me nyuam kawm ntawv uas muaj teeb meem loj txog kev xiam oob qhab (raws li tau tsim los ntawm lawv qhov kev kawm pab cuam) yog tsim nyog los mus koom california Alternate Assessments (CAAs). 3.2 Grading Txoj cai

Raws li cov txheej txheem tsim los ntawm lub tsev kawm ntawv ntawm California, cov qib kawm nyob rau li 8 semesters ntawm Honors los yog AP courses (noj nyob rau hauv cov neeg tshaj los yog senior xyoo xwb) yuav raug suav rau ib teev ntawm A-5, B-4, thiab C-3 thiab nyob rau hauv cov ntsiab lus uas siv los laij tus me nyuam kawm ntawv qib qis.
